Now a day the institute provides UG as well as PG education to students of Arts, Commerce and Science faculty.

2. About AES:

Adarsh Education Society's Arts, Commerce and Science College, Hingoli is an institution established and governed by Adarsh Education Society's Dist. Hingoli, the institution is the institute is 2(f), 12(B) approved by UGC New Delhi, Govt of Maharashtra and affiliated to SRTM University, Nanded catering the education at different levels of UG and PG.

3. Purpose and Scope of MoU

The purpose of signing this MoU is to provide academic cooperation of either side by supporting faculties through internal quality assurance cell in the form of academic cooperation for quality sustenance and quality culture development and knowledge sharing. 4. Resources exchange

5. Funding:

This MoU does not include the exchange of funds between the two parties; the cost generated for any activity would be bare by the party itself.

6. Record Retention:

Records generated out of the activities would be used and retained by both parties as per their requirements and needs with mutual consents of each other.

7. Mere understanding

This MoU only represents a basis of understanding between TACSCS and AES towards one or more formal agreement as may be executed by the institutions. It is clarified that this MoU does not constitute an agreement and therefore is not enforceable as an agreement.

8. Arbitration clause

If any dispute persisted regarding any aspects of academic cooperation, Principal, TACSCS and Principal, AES will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

9. Term and termination

- i. This MoU shall remain in force for an initial period of five (5) years from the date of signing unless its validity is renewed for a further period mutually agreed by both institutions.
- ii. This MoU may be terminated/renewed at any time by either institution with/without mutual consent.

10. Signed in duplicate

This MoU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institutes acting by their duly authorized officer, have caused this MoU to be executed, effective as of the day and year first above written.
