

Purpose and Scope of MoU

The purpose of signing this MoU is to provide academic cooperation of either side by supporting faculties through internal quality assurance cell in the form of academic cooperation for quality sustenance and quality culture development and knowledge sharing. 3. Resources exchange

5. Record Retention:

6. Mere understanding

This MoU only represents a basis of understanding between TACSCS and LPPCR towards one or more formal agreement as may be executed by the institutions. It is clarified that this MoU does not constitute an agreement and therefore is not enforceable as an agreement.

7. Arbitration clause

If any dispute persisted regarding any aspects of academic cooperation, Principal, TACSCS and Principal, LPPCR will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

8. Term and termination

- This MoU shall remain in force for an initial period of five (5) years from the date of signing unless its
 validity is renewed for a further period mutually agreed by both institutions.
- ii. This MoU may be terminated/renewed at any time by either institution with/without mutual consent.
